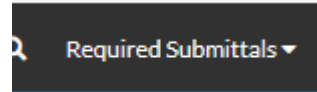

12. Click Next to proceed with Step 6, where you can review your application, including documents attached before submitting it. Once ready, click Submit at the bottom right-hand



side of the page:

13. Your application is now submitted, please use the **Add Cart** button on the right to pay for the applicable invoice. The City will review your request and process your license. As updates are made to your case, the case status will change, keeping you informed of the process.
