


# Clean Power Alliance is Southern California's reliable clean energy provider

Clean Power Alliance (CPA) is a publicly owned not-for-profit electricity provider, offering clean energy choices at competitive rates. We serve more than three million residents and businesses across 32 communities in Los Angeles and Ventura counties. We lead the nation in serving the most customers with 100% renewable energy!

You become eligible for CPA services when your city becomes a CPA member and selects a preferred energy option for residents and businesses. Once service launches, you become a CPA customer without having to take additional action. CPA customers always have the power of choice to select the energy option that is best for them or opt out of CPA service and select another electricity provider.

# CPA is different from other electricity providers

CPA is one of 25 Community Choice Aggregators (CCAs) across California. CCAs were enabled by state legislation in 2002 to provide consumer choice, competition and innovation, local control, and tools for climate action and resilience.

CPA is governed by a board of directors made up of local elected officials from each of the 32 communities we serve. CPA is a public not-for-profit organization rather than investor-owned, and our board meetings are open to the public. Our net revenues are reinvested directly into the communities we serve to strengthen critical infrastructure, fund energy and cost saving programs for customers, and train the workforce for green economy jobs.

### **Power sources**

Clean Power Alliance secures clean power from sources including wind, solar, small hydroelectric, and geothermal to make Southern California communities greener and healthier. Our diverse mix of power sources and CPA's energy storage facilities ensure reliable energy supply for our customers and moves us closer to a sustainable energy future.



## **Delivery**

CPA purchases clean power (wind, solar, small hydroelectric, and geothermal) and Southern California Edison (SCE) delivers it to your home or business. SCE sends you a single monthly bill which includes SCE charges for electricity delivery and CPA charges for electricity supply/generation. CPA charges are not an added fee — they simply replace the SCE supply/generation charges on your bill.
