United States Army, Infantry Lieutenant Christopher Motia is currently deployed supporting Operation Inherent Resolve. He comes from a family of veterans and is continuing his family legacy. It is only fitting that his birthday also falls on Veterans Day!



United States Navy, Lieutenant Mark Kindhouse is currently deployed to a combat zone in Africa. His sacrifice and dedication to service are both inspiring and humbling. Although he will not see his banner this year, it will serve as a reminder for his wife and sons that he is not alone in his journey.



United States Army, W. Donald Foley is 93 years young and stands as one of the oldest living veterans in LCF, proudly serving during the Korean War. Beyond his valiant service in the military, Mr. Foley's life story is punctuated by another remarkable feat—a daring act of heroism that saved two young lives. ### Stay Safe and Dry This Winter Season

SANDBAG LOCATION

For many, the holiday season involves traditions, time with the family and gift exchanges. This time of year, it's also important to take preventative measures to protect your home and prepare for the winter weather. Check out these helpful tips to keep this holiday season a joyous one:

- 1 Leave your travel plans off social media. Instead, tell a trusted neighbor when you will be away, or enlist the help of the Crescenta Valley Sheriff Station's Vacation Patrol Check program by visiting the station. Call Crescenta Valley Sheriff Station for more information, (818) 248-3464.
- Protect your packages by bringing deliveries into your home as soon as possible.
- 3 Place a temporary "stop mail delivery" through the USPS for extended leave of absence. Stop into the local post office or visit the USPS website—it's EASY!
- 4 To prevent electrical fires, inspect your holiday decorations for any frayed cords and use timers for your lights. Avoid daisy chaining holiday lights as much as possible.
- If the power goes out during a storm, use flashlights and battery lanterns instead of candles or gas lanterns to prevent fires.
- 6 If needed, take advantage of the City's sandbag distribution locations. Sandbags can be stacked to decrease the likelihood of adverse effects from excess water runoff.

### Rebate Program Offers Residents

## Incentives to be Safe

The City of La Cañada Flintridge encourages residents to safeguard their homes—and through a new security camera rebate program—there is an opportunity to protect your home and save money.

On a first-come, first-served basis, residents who install a security camera and provide proof of installation and purchase can receive up to a \$100 rebate from the City on a qualifying purchase (camera only, installation costs are not qualified for the rebate).

To participate, residents must meet the following guidelines:

- Be a current La Cañada Flintridge resident with proof of residency on a valid government-issued ID
- Provide a current utility bill that matches the name and address on the proof of residency ID
- Own or rent the residence where the security camera is installed
- If renting, provide a signed letter from the property owner giving consent to the installation
- · Limit one camera per address

Eligible residents can apply to be consider for the \$100 rebate by completing the following steps:

Submit an application online at CityOfLCF.org/public-safety

- · Upload proof of residency on a valid government-issued ID
- Upload a current utility bill that matches the name and address on the proof of residency ID
- Upload proof of purchase AFTER the program went live on November 13, 2023
- Upload photo of the opened devices with the serial/model number visible
- Upload proof of installation with a date stamped photo showing installation took place after November 13, 2023

In compliance with State law, LCF has a Climate Action Plan (CAP), which is in the process of being updated to set new programs and standards.

Since September 2022, the City has partnered with Blue Strike Environmental to update the CAP to assess vulnerability to climate-related impacts and build resilience to current and future climate threats.

## Stay Alert Through Your Local Neighborhood Watch Program

Protecting the community of La Cañada Flintridge remains a top priority for our City, and it's especially important for residents to remain vigilant during the holidays. By taking proactive measures to help prevent crime before it happens, you'll help ensure that this holiday season is a joyous and safe time for our community.

The Neighborhood Watch Program, a partnership between the City and Crescenta Valley Sheriff's Station (CVSS), aims to increase safety and security in local neighborhoods through proactive education, communication and action. The City's Community Liaison and retired CVSS Deputy Eric Matejka, trains neighborhood watch groups to achieve these goals. The programming includes a review of neighborhood and community crime trends and the distribution of handouts and tips to keep your home safe.

# Housing Element Update

The La Cañada Flintridge City Council approved amendments to the General Plan Land Use Element, Zoning Code, Zoning Map and Downtown Village Specific Plan as part of its implementation of the adopted 2021-2029 Housing Element.

Formally adopted at the September 19 Council meeting, the actions now promote more housing development than ever before. The new zoning allows for an additional 684 housing units, of which 612 accommodate affordable housing units, in compliance with State law.

"After public meetings with the Planning Commission, study sessions and workshops, we are proud to see this update coming to fruition," said Director of Community Development Susan Koleda. "For the last two years, the Community Development Department has been working hard to balance State requirements with the character of the community to create a Housing Element that meets resident desires."

With the implementation of updated zoning, the current draft of the Housing Element is under review by the Department of Housing and Community Development.

## Local Municipal Election in March 2024



The next City of La Cañada Flintridge General Municipal Election will be held on March 5, 2024, for three seats on the City Council. The City's election is being consolidated with the presidential primary election conducted by the Los Angeles County Registrar-Recorder/County Clerk.

The nomination period begins at 7 a.m. on Monday, November 13, and closes at 5 p.m. on Friday, December 8. If nomination documents from an incumbent are not filed by 5 p.m. on December 8, the nomination period will be extended until 5 p.m. on December 13, for persons other than the incumbent.
