### Love Blooms With Flower Power

Since 1978, the La Cañada Tournament of Roses Association (LCTRA) has made pigs and dinosaurs fly, origami dragons bend to the will of a wizard, dogs perform on skateboards and brought the dodo back from extinction. The 2024 entry was equally as amazing, as the organization created a flower-based tribute band to the Summer of Love including 'groubees' tagging along in a psychedelic bus. Featuring four band members all taller than 16 feet, the drumming daisy, guitar-wielding iris, bass-slapping sunflower and singing snapdragon all wowed spectators and took home the Golden State Award for the most outstanding depiction of life in California.

Ever wonder about what goes into the process of building a float for the country's most well-known parade? Funding, design and construction of each year's float is a year-long City, LCTRA, Community and volunteer project that welcomes the participation from all in the community.





January: picking a float design, creating a color drawing, designing the needed structures and mechanisms

February-May: dismantling the prior year's float

May-September: building the current year's float

June: mechanical inspection

September: Technical Inspection 1: float skeleton must pass a road test by the Pasadena Tournament of Roses

October: opening volunteer signup, vetting the flower order and finalizing the electronic press kit

First week of December: closing the float's skeleton and Technical Inspection 2: a dress rehearsal of all float components by the Pasadena Tournament of Roses

Last weeks of December: the float is moved and the final decorating process begins

New Year's Eve: the float begins its journey to the parade in Pasadena

A celebration of love, nature and music, the 2024 float is a tribute to peace and gratitude as our community ushers in 2024.



A Powerful Tool in Home Security

An alarm system is an effective deterrent, with signage showing potential intruders that the property is protected. Equipped with surveillance cameras and sensors, alarm systems promptly notify law enforcement, enhance individual security and strengthen the safety of the La Cañada Flintridge community.

While an alarm system serves as the foundational element of home security, its effectiveness can be enhanced through additional preventive actions. Ensuring that all entry points are equipped with sturdy locks, investing in motion-activated lights and utilizing existing programs and resources, such as the Crescenta Valley Sheriff Station's Vacation Patrol Checks and the City's Neighborhood Watch Programs, are among the extra measures that residents can take to elevate their overall home security.

By deterring burglaries, ensuring rapid response and embracing modern technology, residents can fortify their homes and foster increased security throughout our beautiful City.

# The Debut of "Sister Cites Friendship Path"

The City of La Cañada Flintridge is pleased to announce the anticipated completion of the Sister Cities Friendship Path in spring of 2024, funded by the Regional Park and Open Space District (RPOSD).

For more than 25 years, the RPOSD has awarded \$1.5 billion in grants to agencies and community-based organizations for park, recreational facility, trail and open space improvement projects.

When selecting a trail to benefit from this funding, the City found that the existing Descanso Trail entrance into Cherry Canyon was difficult for trail users due to its 15% slope and required equestrian users to dismount and walk the trail. After analyzing the terrain, City staff identified an alternative route near the trail, providing access to the canyon at a more manageable slope of approximately 8%.

This alternate route has been converted into a new, approximately 1,600-foot-long path named Sister Cites Friendship Path in honor of the relationship with LCF's sister city, Villanueva de la Cañada, Spain.

# Pathways to Road Safety

In a community where bike lanes and sidewalks weave through our surroundings, safety remains a shared responsibility between **drivers**, **pedestrians** and **cyclists**.

Pedestrians should walk against traffic, stay on sidewalks and follow traffic signals. It is important to stay visible while walking, especially during darker conditions, by wearing bright or reflective clothing.

Cyclists should follow the flow of traffic, following the direction of cars. When turning or stopping, use the proper hand signals. Cyclists are required to adhere to traffic laws similar to vehicles. They must stop at a stop sign, wait at a red signal, etc. Always wear a helmet to protect yourself in the event of an accident.

E-bikes have grown in popularity.

However, due to their increased speed and power, e-bikes can pose risks to both riders and pedestrians, especially when operated recklessly or without proper safety precautions. Riders should be properly trained and wear a helmet at all times.

As a **driver**, remain vigilant and watch for individuals at intersections and crosswalks. Obey speed limits and be prepared to yield the right of way. Creating a community where each road user prioritizes safety will ensure that all members of LCF can travel with confidence and security.



# Energy Options, Powered by Residents

In November 2023, the La Cañada Flintridge City Council approved membership in the Clean Power Alliance (CPA) to give residents and businesses greater access to renewable energy options through Community Choice Aggregation.

# What is Community Choice Aggregation?

Community Choice Aggregation (CCA) is a program that allows cities and counties to procure electricity for customers by unbundling electricity generation from electricity delivery. For La Cañada Flintridge, this means using CPA to supply electricity and continuing to use Southern California Edison (SCE) for delivery.

#### How do I opt out?

All customers will have the option of opting out of receiving CPA services at any time or changing their tier rate by contacting the CPA customer service.

# How will this affect LCF electricity services?

Residents and businesses should see no impact on their electricity services. All customers will have the option of opting out of CPA services or changing their tier rate. All customers will continue to receive bills directly from SCE.

### When is the transition to Clean Power Alliance?

The transition to CPA generation services is expected to be completed in October 2025. City staff, in coordination with CPA, will continue outreach and education about the transition.
