



30-Day Look-Ahead Construction Activities

The City's contractor, Powell Constructors, Inc., continues their work on the five new soundwall segments a part of the Soundwall Construction I-210 Freeway Phases II & IV Project. Below is information regarding ongoing construction activities for the month of July 2024.

Full Connector & Ramp Closures

Soundwall along Westbound I-210 Freeway (S298; north side of I-210 Freeway)

WHAT/WHY: The City's contractor, Powell Constructors, Inc., is expected to implement a full connector closure, partial lane closures on the freeway and a full off-ramp closure, all during nighttime, for various construction activities.

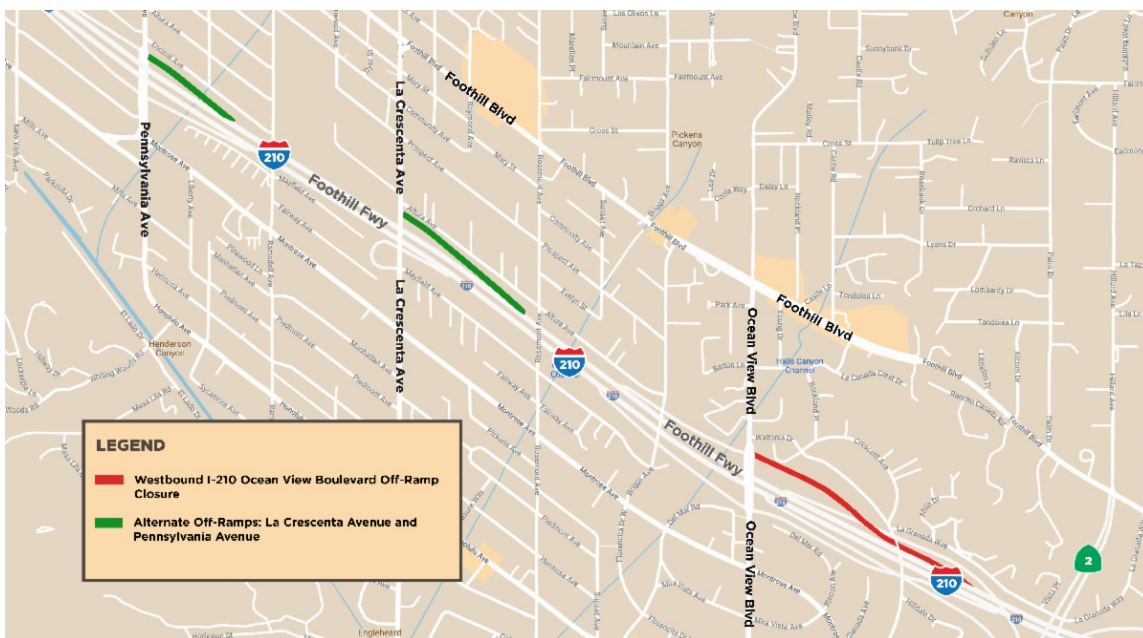
WHEN: **Weeknights**, 10 p.m. to 6 a.m., Monday, July 1 through Wednesday, July 31, 2024.*

**Construction activity schedules and closures are subject to change due unforeseen operational or uncontrollable factors. Please check back for any updates to the night work/closures schedule.*

WHERE: *(See map below for closures, detours & alternate ramps)*

- **Closure:** Northbound SR-2 connector to Westbound I-210
 - **Detour:** Northbound SR-2 to Foothill Blvd. off-ramp > westbound on Foothill Blvd. > southbound on Ocean View Blvd. > on-ramp to westbound I-210
- **Closure:** Westbound I-210 Ocean View Blvd. off-ramp
 - **Alternate off-ramp:** La Crescenta Ave. off-ramp
- **Westbound I-210 partial freeway lane closures;** *at least one lane will remain open at all times.*

Soundwall along Westbound I-210 Freeway (S300; north side of I-210 Freeway)

WHAT: Crews will be carrying out the following activities: (*night work; see below for schedule*)

- Base paving
- Install permanent crash cushion
- Re-grade slope and remove construction materials

WHERE: Between Purtell Drive and Vista Place (in Caltrans' right-of-way).

WHEN: Weekdays, 7 a.m. to 3:30 p.m., ongoing through July 2024

*Please note that some of the above work may be conducted during the night on Monday, July 1 and Tuesday, July 2, 2024, from 10 p.m. to 6 a.m.
Remaining construction activities for this soundwall will continue through October 2024.*

WHY: For the construction of the soundwall.

Soundwall along Westbound I-210 Freeway (S318; north side of I-210 Freeway)

WHAT: Crews will be carrying out the following activities:

- Removal of temporary support structures and clean-up

WHERE: Between La Cañada Boulevard and Angeles Crest Highway (in Caltrans' right-of-way).

WHEN: Weekdays, 7 a.m. to 3:30 p.m., ongoing through June 2024.

Remaining construction activities for this soundwall will continue through July 2024.

WHY: For the construction of the soundwall.

Soundwall along Eastbound I-210 Freeway (S307; south side of I-210 Freeway)

WHAT: Crews will be carrying out the following activities:

- Placement of decomposed granite
- Complete construction of the soundwall gap

WHERE: Between La Tour Way and Alta Canyon Road (in Caltrans' right-of-way).

WHEN: Weekdays, 7 a.m. to 3:30 p.m., ongoing through May 2024.

Remaining construction activities for this soundwall will continue through August 2024.

WHY: For the construction of the soundwall.

During applicable activities, traffic on City streets and noise level may be impacted. However, the Contractor and the Consultant will monitor the noise level to ensure that it will not exceed 85 decibels in accordance with the project specifications. Additionally, traffic control measures will be implemented to ease any congestion.

To ensure safety to the community, the contractor will continuously monitor all activities and adjust conditions as necessary.
